	e VII : Elections					
	Elections will occur at the Annual General Meeting (AGM), which will be held during a business day within a 2-week period on or before March 31st. Exact dates will be announced at least a week in advance.					
	☐ The election process will be run by a neutral Succession Officer, who will be nominated and approved by the General Members before the election period begins.					
	General Members who would like to run for Executive Membership must obtain the signature of two (2) distinct General Members on their nomination form to be a candidate in the election.					
	☐ A Member cannot nominate themselves.					
	The vote shall be held at the AGM following three (3) minute speeches by each of the candidates, with the options of 'For', 'No Confidence' and 'Abstain' for contested and uncontested positions.					
	☐ A candidate must have more votes than all other candidates to win the contested election. In the case of a tied vote, a tie breaker solution will be devised by the Succession Officer.

Al calls for impeachment must be explained during the AGM. If at least 66% of the General Members present at the meeting vote for impeachment, the Executive Member in question will be impeached from their office and as a member of the club.				
	When impeached, an Executive Member will be removed from their position. An election for the empty position will be held at least 5 business days after the impeachment occurs to allow candidates time to prepare.				
	Membership Impeachment:				
	☐ Grounds for impeachment of a club member include any violation of the constitution, the governing documents of CUSA, and committing an act (or acts) which negatively affects and/or harms the interests of the clubs and its members.				
	Any member can bring forward a request for impeachment to any executive. Within 10 days of receiving this request, the executive will host a meeting. At this meeting, the complaint will be reviewed. The individual bringing forward the complaint and the person accused shall be given time to speak.				
	□ A vote for impeachment within the executive will be conducted. A simple majority of executives will be needed to impeach the member. Impeachment of a member results in their removal as a member of the club.				
Article	e IX : Amendments
