

CONSTITUTION OF CARLETON UNIVERSITY YOUNG LIBERALS

Article I

Name of the Organization

The Organization shall be known as “Carleton University Young Liberals”, and herein be referred to as “CUYL.” No other name shall be used in the advertisement or representation of the club.

Article II

Purpose of the Organization

The organization shall work towards:

1. CUYL missions;
 - a. The advocacy and support of the principles and policies found within the Liberal Party of Canada (LPC) and the Ontario Liberal Party (OLP);
 - b. To advocate and support principles and policies within the Young Liberals of Canada (YLC) and Ontario Young Liberals (OYL) for Carleton University students;
 - c. Encourage the Carleton student body into local, provincial or federal Liberal-affiliated nominations, events etc...
2. CUYL vision:
 - a. To provide resources and a forum for like-minded Carleton University students in order to participate actively in Liberal-affiliated events and knowledge.
3. CUYL objectives and goals;
 - a. To provide and ensure CUYL events, visions and missions are carried out effectively;
 - b. Grow the active participation of Carleton University students in CUYL, OYL, YLC, LPC and OLP events and organizations on and off campus.

Article III

Structure

1. The General Membership shall be the legislative body of the organization and shall be composed of all members.
2. The Executive shall be the administrative body of the organization and shall be composed of members elected by the General Membership.
 - a. The Executive body is categorized as follows:
 - i. President
 - ii. Vice President

- iii. Provincial Director;
 - iv. Federal Director;
 - v. Membership Director;
 - vi. Organization Director;
 - vii. Finance Director;
 - viii. Policy Director;
 - ix. Communications Director;
 - x. Graduate Student Executive.
3. The Graduate Student Executive member does not maintain any voting capacity, the role is reserved to advise and aid the executive body.

Article IV

Membership

1. The Organization's General Membership shall be open to all undergraduate students at Carleton University. The club's membership cannot be exclusive towards any group of students at Carleton University.
2. The Organization may grant graduate students at Carleton University and others in the community membership in the Organization, however they must not have voting rights in elections and must have a membership classification in Article III - Structure.
3. Membership in the organization shall be valid from May to April each academic year.
4. Only undergraduate students enrolled at Carleton University may serve on the Executive. Graduate students may only serve a non-voting, advisory capacity.

Article V

Executive

1. The President shall:
 - a. Oversee the other executives in the performance of their duties;
 - b. Provide updates to executive members and general members about the state of the club and recommend to their consideration such measures they shall judge necessary and expedient;
 - c. Represent the Organization in dealings with other organizations, including, but not limited to, other clubs, Carleton University, and the Carleton University Students' Association.
2. The Vice-President of Finance shall:
 - a. Manage the finances and assets of the club;
 - b. Prepare a budget for the Organization each year, or more frequently as events require, and keep records of the financial transactions of the Organization;
 - c. Arrange the funding of social events of the Organization;

- d. Provide updates to executive members and general members about the state of the club as it relates to matters of finance;
 - e. Have signing authority for the Organization.
 3. The Communications Director shall:
 - a. Manage chosen methods of communication such as; social media accounts and email account;
 - b. Prepare organization messages and messaging such as posters, social media posts, and mass emails;
 - c. Provide updates to executive members and general members about the state of the club as it relates to matters of communication;
 4. The Membership Director shall:
 - a. Manage the membership list and oversee its accuracy;
 - b. Oversee internal communication servers used in order to follow the policies of said server, local laws and by-laws, Carleton University, and CUSA. Report any membership issues to the President, and other appropriate agents such as the Office of Student Affairs or the Club's Oversight Commission;
 - c. Provide updates to executive members and general members about the state of the club as it relates to matters of membership.
 5. The Organization Director shall:
 - a. Manage and prepare events and activities;
 - b. Coordinate with Executive members and members of CUYL in order to follow the club's vision, membership desires and finances;
 - c. Provide updates to executive members and general members about the state of the club as it relates to matters of organization.
 6. The Policy Director shall:
 - a. Actively supervise the executive and general membership to adhere to Carleton University Policies and Procedures within the club capacity;
 - b. Provide communication between the executive and general membership;
 - c. Provide updates to executive members and general members about the state of the club as it relates to internal matters.
 7. The Provincial Director shall:
 - a. Provide communication and organization between the Executive, OLP and OYL;
 - b. Direct club mission and goal updates to executive members and general members as it relates to provincial Liberal affairs;
 - c. Maintain awareness of provincial Liberal affairs and news
 8. The Federal Director shall:
 - a. Provide communication and organization between the Executive, LPC and YLC;
 - b. Direct club mission and goal updates to executive members and general members as it relates to federal Liberal affairs;
 - c. Maintain awareness of federal Liberal affairs and news.

Article VI

Meetings

Meetings of the General Membership

1. Meetings of the General Membership can be called:
 - a. At the request of the President, for a meeting to be held not less than one week from the date of publication of the notice;
 - b. At the request of the Executive, for a meeting to be held not less than one week from the date of publication of the notice; or
 - c. At the request of any five members of the Organization.
2. A minimum of one meeting of the General Membership must occur per year in the spring or fall for the purpose of elections.
3. Quorum of the General Membership
 - o The presence of at least five members or the majority of members, whichever is more, shall be necessary to constitute a meeting of General Membership for the exercise of its powers

Meetings of the Executive Committee

1. Meetings of the Executive Committee shall
 - a. Be held at regular intervals and are for the purpose of running the club.
 - b. Votes by the Executive Committee on club business shall be declared by a simple majority.

Article VII

Leadership Succession

Elections

The Organization has chosen to run elections for its Leadership Succession. The following are the steps necessary to be taken to run elections.

1. The Club executives will appoint a Succession Officer to run elections for the Club.
 - a. A Succession Officer may be any one (1) of the following individuals:
 - i. A neutral party to all elections being held within the club.
 - ii. A member of the Clubs Oversight Committee.
 - iii. A member of the CUSA Clubs Office.
 - iv. A club member or an external student non-member.
 - b. All efforts should be made for a Succession Officer to be appointed on a consensus basis in the Executive Committee. When that is not possible, a recorded vote in a first past the post majority or plurality vote winner will be appointed Succession Officer.

- c. The Organization will work with the Succession Officer to set the date of final voting membership purchase, campaign start, campaign end, voting start, and voting end.
 - d. Students-at-large will have the opportunity to join the club before the start of voting.
 - e. Every voter has the right to cast their ballot in private.
 - f. During counting, candidates may select an individual who is not a candidate to be present for counting and scrutinizing.
 - g. Appeals, complaints, or conflict may be made to the Clubs Oversight Committee by way of emailing the Student Groups Administrator.
 - h. Timeline:
 - i. Day 1 - Announcement of campaign, voting, and results announcement dates
 - ii. Day 7 - Start of campaign
 - iii. Day 10 - last day to buy voting memberships for the club
 - iv. Day 14 - end of campaign
 - v. Day 15 - start of voting
 - vi. Day 16 - end of voting
 - vii. Day 17 - Results announced
2. The Club will run a first past the post-style election to elect the executive positions of [insert executive positions]
- a. Candidates on the ballot shall be organized alphabetically by last name, with a box to be filled, marked, or checked for a single option/candidate.
 - b. A final “no-confidence” option will be offered at the bottom of the ballot.
 - c. Any ballot with multiple boxes clearly marked will be discarded as “spoiled.”
 - d. Upon counting of the vote, the candidate with the most votes will be considered elected to the position.

Article VIII

Impeachment

Impeachment

1. To remove a member, our Club will first consult the CUSA Clubs Membership Removal Committee (MRC)
2. The CUSA Clubs Membership Removal Committee (MRC) will advise on the next steps for the club
3. Should the CUSA Clubs Membership Removal Committee (MRC) advise that the club proceed with membership removal, the following steps will take place:
 - a. The member in question will be communicated with directly by a member of the executive body repeating the MRC advice. The member will then be formally

severed from connections to the club including email listing, access to internal club communication servers, and removing the member from the membership list.

4. Impeachment for Removing an Executive Role:

- a. Grounds for impeachment of a club member include any violation of the constitution, the governing documents of CUSA, committing an act (or acts) which negatively affects and/or harms the interests of the clubs and its members, and/or failure to fulfill executive duties.
- b. Any member can bring forward a request for impeachment to any executive. Within 10 days of receiving this request, the executive will host a meeting with the general membership. At this meeting, the complaint will be reviewed. The member bringing forward the complaint and the accused executive shall be given time to speak.
- c. A vote for impeachment with the general membership will be conducted. The accused executive shall not be permitted to vote. A simple majority will be needed to impeach the executive. Impeachment of an executive results in their removal from office and as a member of the club.

5. Membership Impeachment:

- a. Grounds for impeachment of a club member include any violation of the constitution, the governing documents of CUSA, and committing an act (or acts) which negatively affects and/or harms the interests of the clubs and its members.
- b. Any member can bring forward a request for impeachment to any executive. Within 10 days of receiving this request, the executive will host a meeting. At this meeting, the complaint will be reviewed. The individual bringing forward the complaint and the person accused shall be given time to speak.
- c. A vote for impeachment within the executive will be conducted. A simple majority of executives will be needed to impeach the member. Impeachment of a member results in their removal as a member of the club.

Article IX

Amendments

1. Any member can propose an amendment to the constitution. This amendment will be presented at the annual general meeting and a vote will take place with the general membership to adopt the new amendment.
2. A simple majority will be required to adopt the new amendment.

Article X

Dissolution

Upon dissolution of the Organization, all assets gained through CUSA shall be returned to CUSA. All other assets shall be given to the Ottawa Food Bank or to the OYL executive board, whichever the CUYL executive body deems appropriate upon dissolution.
